1. The deposit is **non-refundable** if the client cancels or changes the engagement. There will be an additional 6% **convenience fee** added to the deposit if paid by Credit Card or PayPal.
2. Final balance due at the end of the event. Failure to pay the balance off in time will result in **\$50 late fee**. Final payment will be **CASH ONLY**.
3. The Client shall reimburse Photographer for any additional costs the Photographer may incur for travel, meals, parking, and other reasonable costs necessary to the performance of these services.
4. Photographer takes utmost care with respect to the delivery of photographs. However, in the event the photographer fails to comply with the terms of the contract, due to any event or act outside his control, the liability is to refund the deposit.
5. The photographer will not be responsible for any image loss as a direct or indirect result of computer/camera, disk/media corruption and any related incident during and after the event.
6. Should there be need to extend the time outside of the contractual agreement, extended duration will be calculated in 30 minute increments AND the cost of the half hour will be hourly rate that was previously agreed.
7. The Client shall assist and cooperate with the Photographer in obtaining the desired photographs, including but not limited to specifying persons and/or scenes to be photographed; taking time to pose for photographs at the Photographer's direction; providing a person to guide the Photographer to desired persons and/or scenes; pre-shoot consultations, etc. The Photographer shall not be responsible for photographs not taken as a result of the Client's failure to provide reasonable assistance or cooperation.
8. The Photographer retains copyright of the photographs, and hereby grants the Client unlimited but non-exclusive rights to use or reproduce the photographs for which the Client pays. The Photographer will not use the client photographs for commercial or any undisclosed purpose other than for personal portfolio. However, client may obtain the copyright and **EXCLUSIVE** rights to the photographs for an additional \$199.
